Note that the agency's approval of the postponed campus(es) will become null and void should the charter holder fail to open the campus(es) by August 1, 2016. Any expansion to the charter's geographic boundary which was associated with the proposed campus(es) is forfeited.

The approval of new campus(es) is contingent upon the receipt of certificates of occupancy (COO's), or equivalent certificates, appropriate for the proposed use of the facilities. Please submit the COO's, or equivalent certificates, for the new facilities to the Division of Charter School Administration prior to serving students. Failure to provide the COO's, or appropriate certificates, may result in funding being denied or reclaimed.

*North Hills Expansion Amendments*

WHEREAS, Uplift Education, a Texas nonprofit corporation ( “Uplift”), is currently the charter holder for Uplift Education – North Hills Preparatory School (“North Hills”); and

WHEREAS, Uplift is the charter holder for five charters granted by the State of Texas (North Hills – 057803; Peak – 057838, Williams – 057842, Hampton – 057843, and Summit International – 220816); and

WHEREAS, the Board of Uplift has previously approved a resolution to consolidate the existing charters held by Uplift with North Hills being the surviving charter; and

WHEREAS, to accomplish the consolidation, it is necessary to add the sites/campuses currently operating under the charters to be consolidated (hereafter referred to as the “expiring charters”) to the North Hills charter and to do so, requires approval of expansion amendments to the North Hills charter to add those sites; and

WHEREAS, the Board of Uplift has considered a business plan for the consolidation and expansion of the North Hills charter, including the addition of the additional campus under the North Hills charter and the related costs as well as funding opportunities, along with the other business plan elements required by the Texas Education Agency; and

WHEREAS, after consideration of the above, the Board has determined that it is the best interest of Uplift to request amendments to the North Hills charter to include the current sites/campuses under the expiring charters.

Therefore, it is

RESOLVED, that the charter of North Hills be amended to authorize as new sites/campuses the locations described on Exhibit A attached hereto, which reflect existing sites/campuses under the expiring charters; and
